





He graduated from Gettysburg College with a history degree and received his masters in finance from Seton Hall University.


In his professional life, he worked in banking and finance and lived in London for five years while working for a British bank.

On the 109th Anniversary of Kiwanis International, January 21, 2024, the Eye of the Tiger eKiwanis Club and its president, Alan Guire, virtually hosted the candidates for Kiwanis International Vice President: Hope Markes (EC&C), Gary Graham (ELAMISSTENN), and Dan Leikvold (MINNDAK). They were each questioned about their beliefs and game plans by Kiwanis Past International President Jim Rochford. Nearly 150 Kiwanis members from around the globe were in attendance.

JIM: Can you share what club you are in and how long you have been in Kiwanis?

HOPE: I have been a member of the Kiwanis Club of Hopewell in Hanover, Jamaica, for 25 years. I joined because a good friend asked me to attend a meeting. My club enjoys working with youth and helping children. We have had many of the same members for years – we are like family.

GARY: I am a member of the Kiwanis Club of Baton Rouge. I joined Kiwanis kicking and screaming in 1990 after my wife's friend asked me several times.

DAN: I joined Kiwanis in 2005 and belong to the Kiwanis Club of Lead in the Northern Black Hills of South Dakota. I was recruited at a 4th of July event shortly after becoming the superintendent of schools.

JIM: In what leadership roles have you served?

HOPE: I have served several roles over the years, including president-elect, president, membership chair, and interclub chair. On the district level, I served as a lieutenant governor from 2003-2004 and as governor of the EC&C district from 2013-2014.

GARY: I served as club president from 1999 to 2000. I had great mentors and worked on several committees. I served as club leadership education instructor and as membership chair. In 2005, I served as lieutenant governor under Katrina Baranko. I have served as a district trustee and district membership chair, and I currently serve as a Kiwanis International board trustee.

DAN: When I served as club president, I had no intention of continuing. Obviously, I did and became lieutenant governor. I loved being lieutenant governor and enjoyed that position the most. I ran for governor and won. As the MINNDAK district membership coordinator, I decided to run for international trustee. I believe my role as an international trustee has prepared me well for the position of international president. It's a complicated job, and I have become comfortable working with people from many cultures.

JIM: What stood out during your year as governor?

HOPE: I can bridge gaps - I believe that is my strong suit. I loved traveling throughout my district, meeting members, and working together to resolve challenges.

GARY: I enjoyed traveling and meeting with clubs. What I saw encouraged me, and I saw the need to open new clubs – I opened my first club in several years.

DAN: I enjoyed interacting with members of my district. Because of my career as an educator and superintendent, I honed my people skills. I developed an aptitude for getting along with others with different viewpoints, enabling me to govern fairly and counsel wisely.

JIM: How would you address the issue of membership in our organization?

HOPE: Every committee should have membership on its agenda. We all need to contribute to the growth of Kiwanis - opening clubs, growing clubs, and member retention.

GARY: The key is to open new clubs. I recommend a two-pronged approach - building new clubs and nurturing them for over two years. Let's utilize our club coaches!

DAN: We need to focus on building new clubs in order to grow. We must also focus on member retention and recruiting new members into existing clubs. We need to look at how we are managing our resources. All major organizations are struggling. We also need to look more closely at emerging markets, specifically the Asia-Pacific market.

JIM: Do you have any closing remarks?

HOPE: My training in early childhood education helped me in my professional life, especially with troubleshooting and motivation. I believe I should be the eyes and ears of our members, which includes identifying problems and leading with integrity and by example. Sustainable growth is necessary for Kiwanis to continue.

GARY: MY history, including my work experience as a university administrator as well as my experience as a veteran, will help me in my role as international vice president. I have used the skills I learned and applied them to my Kiwanis life. To this day, I am still an SLP chair for Key Club as well as a Circle K advisor. I have a lot of experience with kids.

DAN: I firmly believe that leadership matters. We must govern and counsel wisely and be organized to carry out plans. My years as a school administrator and Kiwanis leader have prepared me for the role of international vice president.

Do the Numbers Add Up at Kiwanis International?



This month, our own Jim Rochford interviewed Bob Broderick, Chief Financial Officer of Kiwanis International. They spoke about finances and the future of Kiwanis.

JIM: Can you tell us a little about yourself?

BOB: I grew up near Chicago in northwest Indiana. I moved to Indianapolis 11 years ago to take the position of CFO, which was a new role for KI. I am married and have a 15-year-old daughter.

JIM: What does your position encompass?

BOB: KI is a multi-company global organization. We have six or seven legal entities, including a captive insurance company, Kiwanis Youth, Circle K, and entities in Belgium and Canada. We maintain the books for all these entities. We have staff to work on billing, investments, and transfer of funds between bank accounts. We need a lot of manpower because it can get complicated. My job is to follow the money.

JIM: Do you report directly to the executive director of KI?

BOB: Yes.

JIM: That position will be changing hands shortly. Have you met with Paul Palazzolo yet to work on the transition?

BOB: Yes, I have met with him and have gone over serval things with him. Paul knows the organization well and is a fast learner. We have been having regular meetings, and I anticipate a smooth transition!

JIM: You are also an active Kiwanis member in Indianapolis. How has that played a role in your life?

BOB: I'm a member of the Northwest Indy club. I am passionate about children and have never met a Kiwanian I didn't like. My club does an incredible amount of fundraising – one of my favorites is the annual wine auction, which helps raise funds for the Clothe a Child program.

JIM: What percentage of income comes from KI dues?

BOB: Over half of our income comes from dues alone. All revenue comes from membership – recruiting and retaining members, convention registration, and selling items from our retail store. If your customer base shrinks, then your revenue stream shrinks. The key to success is increasing membership. If we don't open new clubs, we are never going to grow.

JIM: We have reserves in Kiwanis. If we have a down year - how do we make that up?

BOB: Just like any organization, if we are operating at a deficit, we have to liquidate investments (reserves). Our business practice is investments belong to the membership. Right now, our reserves are down to just over \$18.3 million from our \$31 million in 2021. That is a considerable decline in just over two years. We are now at a critical juncture, and we have been selling at a low because of how the market has been. We are looking at a four to five year runway. We have cut as much as we could, and we need to increase membership and dues.

JIM: How many employees do you have now versus when you started your position 11 years ago?

BOB: We are about 13% lower in headcount since a decade ago. However, we are still doing the same amount of programs with fewer employees.

JIM: How active is the executive team as far as planning is concerned?

BOB: The executive team meets every Monday to discuss strategic issues. They recently eliminated another position. We are looking to save money, and we have discussed outsourcing some programs to India. As of now, we have no consulting firms or employees in Southeast Asia; however, we have four or five in Europe. We have to examine where we are spending our money and putting our resources. Asia Pacific is an emerging market.

JIM: What is your best pitch for a dues increase?

BOB: If we don't receive a dues increase, the organization will go out of business. You can't continue to spend more than you take in. We are spending at the same level as we did in 2005. If we continue on the same path, we will become a fraction of what we used to be.

JIM: Can you share your analysis on implementing dues increases?

BOB: I do not like our business model, which has been to go for an extended period without having a dues increase. It's been nine years since our last dues increase, and people don't like the large increases. I have spoken with many people who would prefer smaller increases every year or two as opposed to large increases every several years. The only way to turn it around is through membership growth and a dues increase.

JIM: Thank you for coming by and sharing your insight!

BOB: You're very welcome! I realize I am preaching to the choir. Hope to see many of you at ICON!
